- ¹⁴If 4 oz/A or less used and 1 inch of rainfall/irrigation received after application.

- ¹⁶STS Soybeans can be planted immediately.
- ¹⁷As fallow bed treatment. Prior to planting, treated fallow beds should be thoroughly tilled (incorporated) to a depth of at least 2.5 inches.

- ²⁷Enlist Corn, Cotton and Soybeans can be planted immediately.
- ²⁸Xtend Soybean and Cotton can be planted immediately.
- ²⁹Most 2,4-D labels state rotation to all crops after 90 days or sufficiently dissipated.

The following table consists of herbicide trade and common names and their labeled plant-back restrictions for six major row crops grown in Arkansas. Designations for time periods are as follows:

I – crops can be planted immediately, D – the number of days for crop replant interval, M – the number of months, FY – crops can be planted the following year and FS – the following season. Brand names are subject to change; always read and follow label instructions.
