We're ForGround by Bayer. We reward growers for practicing no-till, strip-till and/or cover crops, and we've just made some MAJOR updates to the [Bayer Carbon Program](#) that make this the BEST time to enroll.

**The Bayer Carbon Program eligibility now includes:**

- **Eligible States** - Expanded our geographic footprint by adding 12 states into our program. Eligible states are: Iowa, Illinois, Indiana, Missouri, Kentucky, Tennessee, Arkansas, Mississippi, Louisiana, Minnesota, Wisconsin, Ohio, Virginia, North Carolina, South Carolina, Georgia, Alabama, Oklahoma, Nebraska, Kansas, North Dakota, South Dakota, Texas, Michigan, California, Florida, Arizona, and New Mexico.
- **Eligible Practices** - Program accepts no-till/strip-till and/or cover crop practices rewarded at \$6 per acre, per practice.<sup>1</sup> We are adding a new Nitrogen Management Program, rewarded at \$4 per acre.<sup>2</sup>
- **Expanded Cash Crops** - In addition to corn, soybeans and wheat, the following crops will now be eligible: barley, sorghum, oats, rye, millet, dry beans, lentils, chickpeas and peas.
- **Early Adoption & Historical Payment** - Fields with practice change on or after August 1, 2019 may be eligible to participate, with the potential to receive up to 4 years of historical practices payment.<sup>3</sup>
- **Renewal Potential** - The program performance period is 5 years with the potential to be renewed up to 3 additional 5 year periods. Practices must continue to be performed during the 10 year retention period.
- **Renewal Bonus** - \$6 per acre, per practice, if the program performance period is renewed for an additional 5 year renewal period.
